







## **Costa Rica Pavilion Event (Green Zone)**

Place: The Costa Rica Pavilion will be in the Green Zone, also known as "La Baleine"

(The Whale) at the Palais des Expositions (Palexpo) in Nice.

Who can attend: Open to public. This Green Zone is an open exhibition area for civil society, academia, research, artists, and businesses, as well as a public area for raising

awareness about ocean protection.

### **Overview**

On the afternoon of June 10th, a three-hour workshop will be held at the Costa Rica Pavilion in the Green Zone, offering a dynamic and inclusive platform to engage a broad public audience on ocean accounting. This open event is designed to introduce Ocean Accounts (OA) to those less familiar with the concept, while also delivering technical insights and showcasing tangible applications.

### **Session highlights**



The Pledge to Advance Ocean Accounts, with opportunities to sign the pledge on-site—this is expected to be **the most accessible and prominent moment for signatories**, making it a key milestone in the campaign.



Country presentations and experiences, including Costa Rica's national roadmap and perspectives from other nations.



A tailored Ocean Accounts training segment adapted for policy audiences.



Thematic demonstrations on the economic dependency on oceans, social and equity accounts, and marine protected area (MPA)/conservation accounts, emphasizing the real-world impact of the system.

## **Key considerations**

While political representation may be lower than at Blue Zone events due to the nature of the Green Zone, this workshop is anticipated to attract a broader public audience, making it a valuable venue for awareness-raising, and stakeholder engagement to capture broader support.

Costa Rica is actively shaping this event, with further planning underway.
